- Channel update
 - Mike and PC Stephenson met with the Army Corps of Engineers last Friday along with city and county representatives
 - The Army Corps acknowledges the need for a new channel, but is still questioning the economic viability of the project under Section 107
 - o There is still some hope the project could be approved, but political pressure may be required
 - The county is a huge supporter
 - o PC Stephenson working closely with city council members to educate them and gain support
 - o If the project is not approved, discussed the value of being "shovel ready" should additional funding become available
